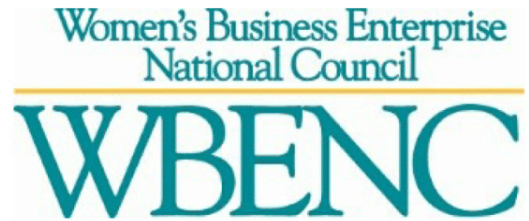


The Women's Business Enterprise National Council (WBENC), founded in 1997, was established to certify women owned business enterprises and to help foster their relationship as suppliers to corporations.
